

Instructions and Conditions

- This reservation only reserves the use of the shelter/site specified. It does not guarantee the exclusive use of other facilities such as ballfields, open areas, restrooms, or parking. They are provided on a first come, first serve basis.
- The Park Officers are on duty to help you have a successful day. Feel free to ask them questions or help resolve any problems you have. As certified Law Enforcement Officers, they do enforce State and Local Laws when situations so require. All Metropark Rules and Regulations apply.
- Cancellation – A cancellation of a reservation will result in the forfeiture of the entire reservation fee. NO REFUNDS. No refunds due to weather.
- Rain Dates - If on your date, Park Administration determines weather conditions will not permit use of the site, your reservation may be rescheduled *once* to any future date not already reserved within the current calendar year. NO REFUNDS.
- Vehicle Entry Fees – Metropark vehicle permits are required on all motor vehicles which enter a Metropark. Park entry fees are not included in the reservation fee unless noted.
- Alcohol – Beer and wine are permitted (no glass bottles) (no hard liquor).
- Damage – Permittee will be held financially responsible for damage beyond normal fair wear and tear and will be billed for excess damage and/or clean up.
- Off-road driving and parking of vehicles inside picnic areas is not allowed. Each shelter will be allowed one (1) escort for picnic supplies, by requesting permission at the park office with the exception of Dexter-Huron and Delhi Metropark which has no access for vehicles. An employee will escort the vehicle to and from the picnic site/shelter on the day of the event.

Stony Creek Metropark

- Sheldon Pines - Reservation for this site guarantees your use from 10 a.m. – 9 p.m. Other amenities are not provided by the park. Site set-up prior to the rented date must be approved by the park office. Permittee is responsible for site cleanup prior to 10 a.m. the following morning of the rental date or be subject to a \$100 fine. Parking at the golf course is not permitted. Guest parking is located at boat launch parking lot. Transportation from parking at boat launch to Sheldon Pines is the responsibility of the reserving party. Use of a generator and any seating required is also the responsibility of the reserving party. No food or beverages allowed at this site.
- Washington Township noise ordinance for Stony Creek Metropark: 124.011 – Musical instruments, radios, record or tape players and sound amplifying devices. Sec 11. No person shall operate or play any musical instruments, radio, mechanical record or tape player, loudspeaker, public address system or sound amplifying equipment of any kind within the boundaries of Stony Creek Metropark in such a manner as to cause the sound emanating therefrom to exceed a loudness of 75 decibels when measured on a 70 db. scale at a distance of 15 feet from the sound source without a written permit issued by the Metroparks. All Metroparks Rules and Regulations apply.

Lake St. Clair Metropark

- All alcohol served or provided within **Thomas Welsh Activity Center** must be purchased, served, and regulated by the park catering service. NO EXCEPTIONS.
- Harrison Township noise ordinance for Lake St. Clair Metropark: Sec. 66-54. - Musical instruments, radios, record or tape players and sound amplifying device. No person shall operate or play any musical instrument, radio, mechanical record, disc or tape player, loudspeaker, public address system or sound amplifying equipment of any kind within the boundaries of Lake St. Clair Metropark in such a manner as to cause the sound emanating to exceed a loudness of 75 decibels when measured on the 70db scale at a distance of 15 feet from the sound source without a written permit issued by the Metroparks.
